# Conditions of Membership and Aims of the Group:

---

1. The Group will be known as the Associated Carpet Group Limited
2. The Aims of the Group
  - A. To have collective strength with regard to buying and to give collective support to those nationally known suppliers of carpets and other floor coverings, including suppliers of ancillary items such as underlay, gripper and metals etc.
  - B. To achieve a degree of exclusivity wherever possible in respect of pattern names, designs and qualities, etc.
  - C. To trade on equal (or better) terms than members of similar groups or multiple outlets.
3. It is a condition of membership that members should not be a member of another group.
4. The Associated Carpet Group Limited expects all members to pay suppliers accounts promptly.
5. The Associated Carpet Group Limited expects all members to pay their annual subscriptions promptly. The amount per year will be determined by the members at the Annual General Meeting, following the recommendations of the Group Treasurer.
6. Members will be invited to attend the Annual General Meetings, or other meetings of importance decided by the management committee or the Board of Directors.
7. Any members wishing to serve on the committee for a minimum period should apply formerly in writing.
8. Members will be required to give notice to the ACG Head Office of any extension to expand their business into another trading territory. If the proposed expansion directly interferes with, or is in close proximity to an existing member then membership may be rescinded.
9. Members will respect the confidential nature of any business concerning the Group or its membership.
10. Members will sign the following undertaking to abide by the above conditions and also those contained in the Articles of Association of the Limited Company, a copy of which, is kept permanently at the Group Head Office. A copy will be forwarded on request.
